



Land described in the schedule below is allotted to Government Higher Secondary School Pakke Kessang, District Pakke Kessang Lemmi for the purpose of school an area measuring 16.61 Acres under Sub-S(1) of Section 12 of the Arunachal Pradesh(Land Settlement and Records) Act-2000 subject to the following conditions namely-

- (1) The allotment shall be liable to be cancelled if:-
 - (a) The allottee committed a breach of any of the conditions mentioned hereinafter or any of the provisions of the Arunachal Pradesh(Land Settlement and Records) Rules, 2012, or
 - (b) At any time it discovered that the allottee was not eligible for this allotment in terms of the Arunachal Pradesh (Land Settlement and Records) Rules, 2012 guilty of misrepresentation at the time of allotment.

Provided that before such cancellation is ordered, a notice is given to the allottee to show cause against cancellation within a period of 15 days from the receipt of the notice.



Kindly refer to your application No.GHSSPK/Acad/CBSE/2023-24 dated 25/07/2024 on the subject cited above. In this connection, it is to inform that the building plans has been scrutinized by this department from fire safety point of view and observed that there is a proposal for construction of Educational Building namely "Govt. Hr. Sec. School" comprising of ground floor only (SPT) with total floor area 1243 Sqm on a total plot area measuring 16.61 Acres.

Therefore, in reference to Arunachal Pradesh Building Bye Laws - 2019, an Educational Building with Floor Area more than 500 Sqm. is considered under occupancy categorization of Residential Buildings Zone-I, Group B (I), a Provisional No Objection Certificate from this department is issued subject to the following compliance/conditions:-

- All Fire Protection Requirements applicable to Educational Building in Zone-I, Group B (I) as specified in Annexure B-I read with Chapter - 11 of APBBL-2019.
- 2. The fire safety installations mentioned in the Proposed Fire Safety Drawings shall be installed in the building upon the completion of construction as per the Undertaking submitted to this office dated 25/07/2024.

Any deviation from the requirements as per APBBL-2019 with regard to construction, fire protection requirements and occupancy thereof, shall be the sole responsibility of the proprietor and in case of any eventuality the onus shall lie squarely upon the Proprietor for any consequent loss of life and property.
- 4. The Proprietor shall ensure that upon completion of construction of the subject property a Completion Certificate is duly obtained from the competent authority after obtaining due clearance from the Director (Fire), Itanagar and occupancy of the building is deemed allowed only after obtaining completion certificate.
